

NTSSA PARENT'S CODE OF CONDUCT

_ Children have more need for example than for criticism.

Attempts to relieve the pressure of the competition not increase it.

_____ A child is easily affected by outside influences. Be kind to your child's coach and officials. The coach is a volunteer, giving of personal time and money to provide a recreational activity for your child.

_____ The opponents are necessary friends; without them your child could not participate. Applaud good plays by your team and by members of the opposing team.

_____ Do not openly question an official's judgment and honesty. Officials are symbols of fair play, integrity and sportsmanship. Accept the results of each game.

_____ Encourage your child to be gracious in victory, and to turn defeat into victory by working towards improvement.

_____ Remember your child is involved in organized sports for their enjoyment, NOT YOURS! Encourage your child to always play by the rules.

_____ Teach your child that honest effort is as important as victory so that the result of each game is accepted without undue disappointment.

_____ Remember that your child learns by example. Children mimic what their parents say. Criticism of the coach, officials, teammates, and/or opponents fosters bad attitudes and can only lead to a negative experience for your child.

_____ Parents should remember that a coach has an entire team of players to consider when making decisions regarding position, playing time, substitutions, and strategy. The team does not revolve around one player.

_____ Inappropriate language and/or behavior at the field will result in being asked to remove yourself from all UCYSA events for one year. We are an organization for the youth of Upshur County. We will strive to create an atmosphere where children feel safe.
